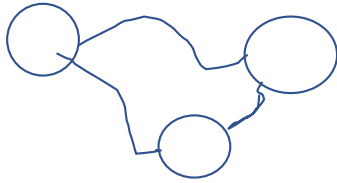


Figure 1. Path coefficients and significance (Rahmah et al., 2016)
